In fact Suffolk was under the most severe fiscal stress of any county in 2018, with a score of 76.7 for the second consecutive year, according to the fiscal index in the report. It should probably have been expected with over \$883 million in debt over the past decade.

Despite the fact that the County's workforce has been reduced by nearly 1,000 workers, payroll has increased by over \$100 million. At the same time, the budget has risen from \$2.7 billion to \$3.1 billion.

The property tax levy has increased from \$532,765,964 in 2012 to \$652,108,097 in 2019. That is an increase of \$119,342,129, meaning that homeowners have seen a property tax increase of 22.4% over that time.

Bellone has hit Suffolk taxpayers hard with across-the-board fee increases. These fees – just another word for taxes -- include

the tax map verification fee, mortgage recording fee, residential/commercial burglar alarm fee, red-light camera fee, shopping bag fee, pet-grooming fee, and Department of Motor Vehicles registration fee.

He also hiked county park use fees every year since 2015 for camping, fishing, hunting, parking, group events and recreational permits. This disproportionately affects working-class Suffolk residents, including first-time homebuyers and those who rely on parks for recreational opportunities. Again, the Bellone

Meanwhile, as Comptroller, Kennedy uncovered waste, fraud, and abuse in county government, saving taxpayers over \$55 million.
